IN APRIL, WE CONSERVED 83.5 MAGNIFICENT ACRES AT PATRIARCH RIDGE IN CARMEL VALLEY. OUR CARR LAKE PARK PROJECT'S NATIVE GARDEN CONTINUES TO THRIVE AT THE SITE IN SALINAS THANKS TO VOLUNTEER GARDENERS OF ALL AGES WHO PARTICIPATED IN PLANTING DAYS WHILE STAYING MASKED AND SOCIALLY DISTANCED. 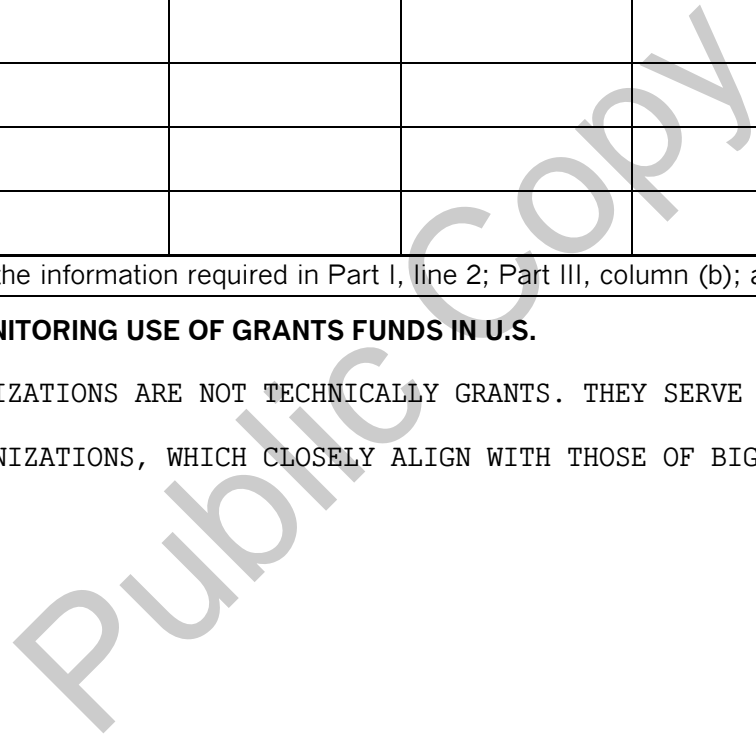
